#### WHAT YOU CREATE.

All types of art and craft - fashion, paintings, photography, drawings, jewelry, decor, random oddities...we don't know. You tell us. We're open to all kinds of stuff. All we ask is that your creations are your own. NO COMMERCIAL PRODUCTS WILL BE ACCEPTED.

This is a juried show. All registrants will be screened and acceptance will be the decision of The Girlie Show Committee. Inclusion in previous year's shows does not guarantee acceptance. The Committee reserves the right to ask vendors to remove questionable (ex: too risqué or commercial) items from their booth.

NOTE: In addition to The Girlie Show finalist list, there will be an Alternates List consisting of five selected applicants. These applicants will have met all criteria for acceptance into The Girlie Show, but were unable to be selected as finalists due to space restrictions. In the event of artist cancellation(s), applicant(s) on the Alternates List will be notified immediately and given the option to participate. You will be notified on your original application reply letter if you are on the Alternates List.

#### WHAT YOU GET.

- 8x8 booth with options for table, linens and chairs.
- (2) FREE admission badges for any helpers you may need throughout the weekend.
- 100% of your sales profits. The Girlie Show does not take any sort of commission or percentage of your sales.
- Option to purchase unlimited Saturday admission tickets in advance for just \$3. (Regular admission price is \$5). You may use these tickets to sell or give to prospective customers, friends, family, etc. to help with your self-promotion efforts.
- Your name, website and image of your work featured on The Girlie Show website for a year following the show.
- Opportunity to promote yourself in the Girlie Goodie Bags Friday night. Girlie Goodie Bags are given free to the first 50 attendees and feature freebies from our vendors and sponsors as well as fun Girlie Show items. These have become a sought-after item! People fight for them!
- Opportunity to showcase your artwork in the VIP room (private room for top-level sponsors). Contact us for details.

**THE GIRLIE SHOW 2008 APPLICATION**

Along with signed application, all vendors must submit a minimum of FOUR photographs of their product(s) that accurately represent items they wish to display in their booth. If photos are available online, please include a website link. In addition, send a jpg file (with a minimum of 150 dpi) of one image that best represents your work for use on The Girlie Show website if accepted. You may include it on a disk or email it. Online submission of your application is considered a signed, dated document. All application documents become the property of The Girlie Show LLC. If you are applying for a Shared or Co-op booth, please note that EACH vendor must apply separately. A Shared or Co-op booth is considered separate businesses sharing a space. A Single booth is considered one company (or vendor) with multiple business partners (that create products together) and should apply under one application.

There is no application fee. Once accepted, booth fees must be paid by Friday, September 25, 2009 and are non-refundable. An additional \$25 will apply for any returned checks.

This is a two-day show. You must be able to participate both days to qualify. Please be sure that you will be able to fulfill the larger quantity demands of a two-day show.
